Regulations Mediterranean Sea for Duty Free fuel bunkers:

Gibraltar: duty free fuel for all yachts regardless of registration.

Spain: only duty paid fuel available.

France: VAT exempt fuel is available for commercial yachts with a valid charter agreement and commercial activity declaration in place.

France: duty free fuel is available for commercial yachts with a French Cruise Contract in place (not with a MYBA charter contract).

France: duty free fuel is available for yachts with a cruise ship registration.

Italy: only duty paid fuel available.

Italy: export fuel is available for all yachts regardless of registration in selected ports providing the next port of call is outside of EU waters. Yacht has to depart within 8 hours after refueling. Please inquire about available ports.

Italy: tax free fuel is available for yachts with a passenger ship registration.

Please note that commercial yachts can claim back the VAT paid through their fiscal rep.

Malta: duty free fuel is available for commercial yachts with a charter agreement in place (no VAT is charged). Yachts have to depart Maltese territorial waters after refueling.

Greece: duty free fuel is available for commercial yachts with a valid charter agreement in place (no VAT is charged). All docs need to be translated into Greek language. This is a service we arrange automatically.

Albania: duty free fuel is available for all yachts regardless of registration status.

Montenegro: only duty paid fuel available.

Turkey: duty free fuel is available for all yachts regardless of registration. Yachts have to depart Turkish territorial waters within 8 hours after refueling and can't come back to Turkey with any tax free fuel remaining in their tanks.

Tunisia: duty free fuel is available for all yachts. Only product available is LS MGO 0.1%.

Algeria: duty free fuel is available for all yachts. Only product available is LS MGO 0.1%.
